The Client Sites will have their content incorporated in those pages that are marked "Content from Client". **THE CLIENT SITES ARE CONSIDERED LEASED SITES AND ARE THE PROPERTY OF THE COMPANY.** The personalized content for each site is the property of the Client.

** The Monthly Fee of \$89.95 will begin on the first day of the month following the confirmed launch date of the Client’s website. The first billing will be for 2 months for a total of \$179.90. This fee will be billed on the Client’s AIS Wholesale Account. If the Client’s website has generated enough profits (after Mandatory Additional Fees) to cover the monthly fee the monthly fee may be deducted from the profits on the account. If the website has not generated enough profits (after Mandatory Additional Fees) to fully cover the monthly fee it will be billed to the Client’s AIS approved Wholesale Account.

*** The Mandatory Additional Fees will be deducted from the revenues generated from the Client’s site. And will be deducted on each transaction as they occur.
